Indiana Parenting Time Guidelines

With this child visitation schedule, the kids reside with the custodial parent and spend alternating weekends with the non-custodial parent. In the example shown here, weekend visits begin at 6:00 p.m. on Friday and end at 6:00 p.m. on Sunday. This is probably the most popular child visitation schedule, especially for newly separated parents.

Creative Options for Child Visitation Schedules

The minimal contact visitation schedule may be appropriate where parents are separated by a long distance and travel is difficult. The children's contact time with Dad is limited to once every other weekend (with a gap of 11+ days between visits). A long gap between visits is detrimental to child development outcomes.
