### Shippers Declaration For Dangerous Goods

To ship dangerous goods, consignors are required to prepare a form certifying that the cargo has been packed, labeled and declared according with the IATA Dangerous Goods Regulations (DGR). The attached sample Shipper's Declarations form reflect those that have been adopted into the 60th edition of the DGR. Forms of the design as shown in the 59th edition may continue to be used until 31 December 2024.

Some dangerous goods, however, do not require completion of The Declaration.

The Department of Transportation (DOT) oversees compliance with the Hazardous Materials Regulations (HMR). Entities and individuals that are subject to the select agent and toxin regulations are also responsible for ensuring compliance with all other applicable federal regulations, including DOT requirements in the HMR for the shipment of select agents and toxins.

☐Emergency Telephone Number - All dangerous goods shipments to, from, within, or transiting through the U.S. must include 24-hour emergency response information as described in IATA 2.9.2, USG-12. ☐Name and Title of Signatory - Enter the name and title of the person actually signing the Shipper's Declaration.

SHIPPER'S DECLARATION I hereby declare that the contents of this consignment are fully and accurately described above by the proper shipping name(s), and are classified, packaged, marked and labeled/placarded, and are in all respects in proper condition for transport according to applicable international and national governmental regulations.

#### IMO Dangerous Goods Declaration - TBGFS

The IMDG Code requires a declaration from the consignor stating that the particular dangerous goods declared are identified, classified, packaged, marked, labeled and placarded correctly. A declaration from the person packing the container is also required to ensure it has been done so correctly.

#### Download Dangerous Goods (Hazmat) Forms

Shipping dangerous goods internationally by vessel is regulated through the International Maritime Organization (IMO). The IMO is a specialized agency of the United Nations. The IMO uses the International Maritime Dangerous Goods Regulations Code (IMDG Code) as the basis for international enforcement of dangerous goods transportation by vessel. 3.

#### IATA shipper's declaration for dangerous goods and ...

Certain fields on the 'Shipper's Declaration for Dangerous Goods' form can be handwritten, including shipper's name, technical name, name/title of signatory, place and date. However, other fields on the form must be completed using software with dangerous goods compliance edit checks.
