What is an MLA In-Text Citation? An in-text citation is a citation within your writing that shows where you found your information, facts, quotes, and research. All MLA in-text citations require the same basic information: Author's last name (no first names or initials) Page number (if available)

MLA format follows the author-page method of in-text citation. This means that the author's last name and the page number(s) from which the quotation or paraphrase is taken must appear in the text, and a complete reference should appear on your Works Cited page.

General rules for each MLA in-text citation: It should correspond to its relevant reference from the works cited page. Every citation should contain the author's last name and the page (or range of pages) where the specific quote or information is found in the original source.

Place the citation in parenthesis before the sentence's terminal punctuation point. For example: If Americans make more health-conscious adjustments to their lifestyles, they could prevent the onset of many chronic ailments, which encompass "some 75% of U.S. health care costs" (Russo, 60).

If the paper has more than one author, list the rest of their names in first name-last name format, separated by commas. Type the word "and" before the last author's name, then place a period at the end.

In MLA citing, if there are two authors with the same surname, be sure to include their first initial in your citation to avoid confusion. Page specified, two authors, same work: Each author's name will be included in both the parenthetical and the full source reference in your MLA bibliography.

If the author's name begins such a citation, place a comma after the name. There is little evidence here for the claim that "Eagleton has belittled the gains of postmodernism" (Chan, par.41). When a source has no page numbers or any other kind of part number, no number should be given in a parenthetical citation.

Citing in the body of your paper - MLA Citation Guide ...

In MLA style, up to two authors are included in citations. List them in the order they appear in the source, separated by commas, and don't invert the second author's name. If an article has three or more authors, include only the first author's name, followed by " et al. " What can proofreading do for your paper?

How to Cite a Journal Article in MLA | Format & Examples

Align the title so it sits in the center of the MLA format paper. The title should be written in standard lettering, without underlines, bold font, italicized font, or any quotation marks. Only include italics if your title includes the title of another source. There should be NO:

MLA Format: Everything You Need to Know Here

In MLA style, all the sources you cite throughout the text of your paper are listed together in full in the Works Cited section, which comes after the main text of your paper. Page numbers: Just as the rest of your paper, the top of the page should retain the right-justified header with your last name and the page number.

As with all MLA citations, when citing a conference paper, you should give the surname of the author and page numbers for the section you're citing: The image included a rabbit, a bat and a reindeer (Lewis 212). The citation above, for example, points to page 212 in a paper by "Lewis."

Examples of in-text citations: According to a study by Smith (qtd. in Kirkey) 42% of doctors would refuse to perform legal euthanasia. Smith (qtd. in Kirkey) states that "even if euthanasia was legal, 42% of doctors would be against this method of assisted dying" (A.10). Example of Reference list citation: Kirkey, Susan. "Euthanasia."
