The other CPT code for pulmonary function testing is 94060 (bronchospasm evaluation: spirometry as in 94010, before and after bronchodilator [aerosol or parenteral]). You should not use 94060 and 94010 on the same day. The bronchodilation is included in the 94060; do not bill for it distinctly. ...

A common pulmonary function laboratory practice is to use the CPT code 94620 (simple exercise test) for the 6-minute walk test. To use this CPT code, however, it would probably be prudent to measure 1 or 2 cardiorespiratory variables (eg, heart rate, pulse oximetry) in addition to noting the exercise toler- ance.
